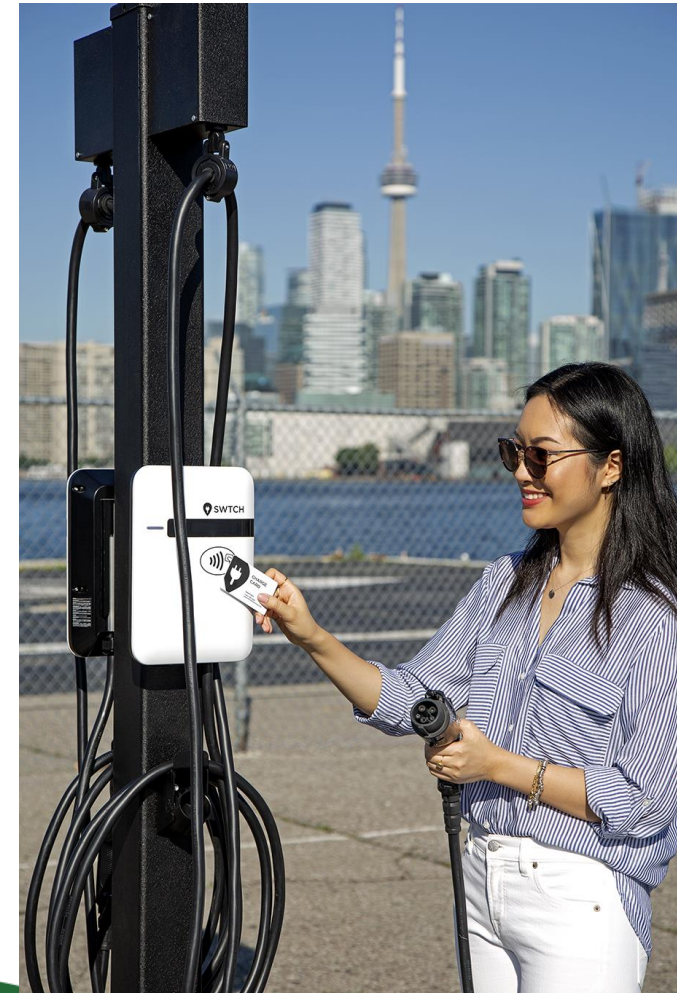
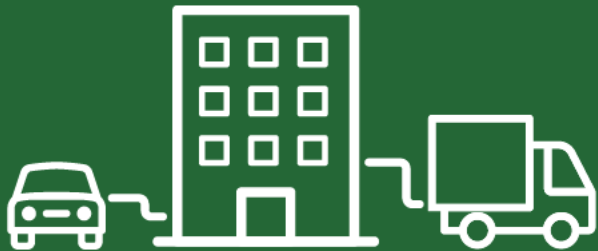
# Economic importance of Ontario's EV industry

## More than ever, the electric mobility industry needs market predictability to thrive

Ontario is uniquely positioned to reap the economic benefits of the global transition to transportation electrification, thanks to its abundant clean energy, qualified workforce, wealth of critical minerals, manufacturing capacity, research expertise, and a growing electric vehicle (EV) industry.

The Ontario government has succeeded in attracting over \$45 billion in EV industry investment over the last few years.

Ontario's 90% non-emitting electricity generation multiplies the benefits of EV adoption.





# Supporting Ontarians where they live

## EVs must be affordable for all

### Recommendations:

- Offer income tested point of sale provincial tax credit for first-time new or used EV buyers only
- Future-proof multi-unit residential buildings (MURBs) through planning with province-wide EV-ready requirements
- Add networked home EV chargers to eligibility list for Ontario's energy efficiency rebate program



# Supporting Ontarians and visitors wherever they go

## Recommendations:

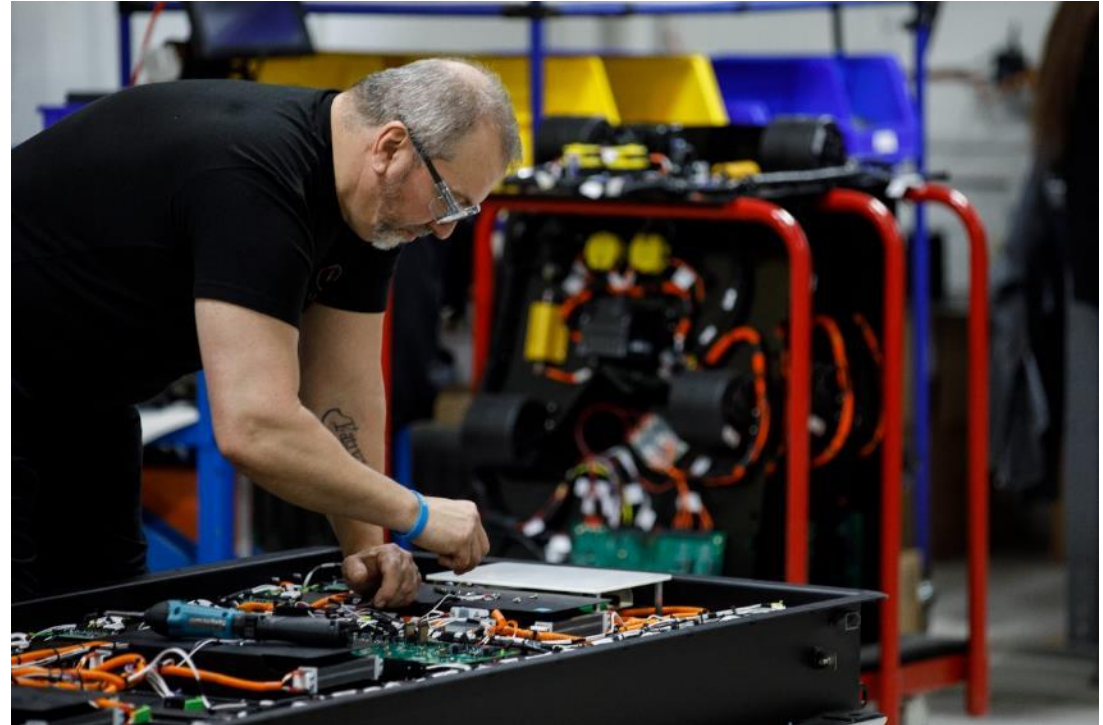
- Increase EV publicly available charging infrastructure deployment for light-, medium- and heavy-duty electric vehicles
- Recapitalize *ChargeON*
- Provide incentives or oversight to ensure EV charging reliability



# Supporting Ontario's Workers

## Recommendations:

- Support the electrification of transit and school buses
- Require public funding be contingent on Canadian made electric transit and school bus purchases
- Train Ontario workers with the expansion of EV skills training and education programs
